All requests for bid clarification must be submitted in writing to the Buyer referenced above and received no later than close of business (5:00 PM Eastern Standard Time) on **Tuesday, June 10, 2014.**

All questions will be answered and documented in writing as an Addendum to the Bid. These will be sent out to all Bidders who received the original Bid no later than **Friday, June 13, 2014.**

DUPLICATE COPIES:

PLEASE SUBMIT YOUR BID IN DUPLICATE; THE ORIGINAL AND ONE (1) COPY.

BID INFORMATION:

At the time of bid, the bidder shall supply detailed specifications covering the item(s) contained herein and shall clearly indicate any areas in which item or items offered do not fully comply with the specifications contained herein.

**SUBMITTAL OF
FORMAL
PROPOSAL:**

Bid proposal must be legible and submitted in the original form, bearing an original signature. **EMAILS AND FACSIMILES ARE NOT ACCEPTABLE.**

All bidders must submit proof that they have obtained the required **Workers' Compensation** and **disability benefits** coverage or proof that they are exempt if awarded the contract.

**SPECIFICATION
ALTERATIONS:**

Specifications will be construed to be complete and be considered the entire description of the goods or services upon which Monroe County is now seeking bids. **Only formal written addenda can materially alter this set of specifications.** No verbal statement made by a Monroe County employee or anyone else is binding nor shall such statement be considered an official part of this public bid proposal.

NYS WAGE RATES:

Pursuant to the provision of Section 220-A of the New York State Labor Law, as amended, the Contractor (and related Subcontractors) will be obligated to pay all workers in the covered classes only the applicable prevailing wage rates and supplements. The minimum hourly wage rate to be paid the various classes of labor performing work under this contract shall be in accordance with schedules which have been established or may hereafter be established or increased, by the New York State Department of Labor during the contract term. **Refer to NYS Wage Schedule PRC# 2014004522 developed for this project.**

QUANTITIES:

The quantities listed are the estimated annual requirements and should not be construed to represent either maximum or minimum quantities to be ordered during the contract term. **Estimates are based upon actual annual usage for the previous contract by County departments and Other Agencies.**

BRAND REFERENCE:

References to a manufacturer's product by brand name or number are done solely to establish the minimum quality and performance characteristics required. Bidders may submit bids on alternates, but must attach two (2) copies of manufacturer specifications for any alternate at the time of the bid. Further, the bidder must demonstrate that the alternate proposed has a sufficient operating track record to show the equipment will perform per the specified brand. The acceptance of a bidder's alternate rests solely with Monroe County.

SAMPLES:

Samples for alternates must be submitted by any bidder at the time of the bid at no additional charge to Monroe County. Failure to provide samples within this time frame may result in rejection of your bid. The county reserves the right to reject any bid where the sample is not equal to the product specified, in both construction and color selection.

**TIME OF
COMPLETIONS:**

All work for a job must be completed within two (2) weeks after the start work order is issued, unless a different time is specifically agreed upon for that particular order, by a Monroe County Department.

QUALIFIED BIDDER:

Each bidder must be prepared to present satisfactory proof of his capacity and ability to perform this contract. Such proof may include, but is not limited to, an inspection of the bidder's facilities and equipment, financial statements, references and performance of similar contracts. **The Purchasing Manager reserves the right to reject any bid where the bidder cannot satisfy the County as to their ability to perform. Monroe County reserves the right to reject any and all bids** if the Monroe County Purchasing Manager deems said action to be in the best interests of Monroe County.

**METHOD OF
AWARD:**

Monroe County intends to award one or more contract(s) to the lowest responsive and responsible bidder(s). The County reserves the right to award the bid as a **whole or by Group, depending on whichever method results in the lowest overall cost to the County. Separate awards will be considered when in the County's best interests to do so, such as when the price offered is great enough to offset the additional costs inherent to multiple contracts. Bidders are not required to bid on every Group included in the bid; however, they must bid on every item within each Group in order to be considered.** Incidental Item pricing cannot exceed market rate. **The County reserves the right to reject any and all bids** if the Purchasing Manager deems said action to be in the best interest of the County.

CONTRACT TERM:

Contract will start with the date of the contract award and run through **June 30, 2015**, with the option to renew the contract up to four (4) additional twelve (12) month periods with the mutual consent of both parties.

PRICE CHANGES:

Price changes may be proposed by either party no later than forty-five (45) days prior to contract extension, based upon manufacturer price changes which must be supported with documentation. Should price changes not be acceptable to both parties, the contract will not be extended. Prices may change only at the time of extension.

MINIMUM ORDER:

No minimum order is specified for this contract. Agencies must be able to order as needed. **Political subdivisions and others authorized by law may participate in this contract.**

DELIVERY:

All deliveries to be F.O.B. Monroe County to agency as specified by a Purchase Order. Delivery costs must be built into the unit prices bid. Deliveries must be made within **two (2) weeks** after receipt of purchase order number. The County reserves the right to terminate the contract in the event the specified delivery time is not met.

**PURCHASE ORDER
ISSUANCE:**

Delivery of services may be directed by the receipt of a Purchase Order only. **Items that are not part of this bid will not be paid for by Monroe County.** As to all purchase orders issued by Monroe County, exceptions may only be authorized, in writing, by the Purchasing Manager or her authorized agent prior to delivery.

**BILLING
PROCEDURE:**

All invoices for items sold any authorized agency as a result of this contract must be billed in the following manner: Purchase Order #, Quantity, Description of Item Purchased, BP#, Item #, Extension and Total. **ALL INVOICES MUST BE MARKED WITH THE PURCHASE ORDER NUMBER. INVOICES WITHOUT THIS INFORMATION WILL NOT BE PROCESSED FOR PAYMENT.**

**WARRANTY/
GUARANTEE:**

All warranties by manufacturer shall apply. Bidder shall, as part of its proposal, furnish its warranty/guarantee for all goods/services to be furnished hereunder. As a minimum, Bidder shall warrant all goods for a period of one (1) year from date of acceptance. Bidder shall be obligated to repair or replace all defects in material or workmanship which are discovered or exist during said period. All labor, parts and transportation shall be at Bidder's expense.

**UNCONTEMPLATED
PURCHASES:**

Monroe County reserves the right to request separate bids for such quantities of items on this contract that may be best procured via separate public bid offering and to otherwise act in furthering its own best interests.

SUBCONTRACT:

The Contractor shall not subcontract any work without first obtaining the written consent of the Monroe County Purchasing Manager.

RELATED ITEMS:

The County reserves the right to add miscellaneous related items to this contract during the contract term upon agreement by both parties as to the price. Approval must be given in writing by the Purchasing Manager or her Designee.

**REPORT OF
PURCHASE:**

The Contractor must, upon request, provide the County Purchasing Manager with detailed information showing how much of each item was delivered, to any and all agencies under this contract. This includes deliveries to not only the County but any other municipality or agency which orders from this contract.

DAMAGES:

Any damages found by the county to be the direct result of the Contractor's performance of services in this contract will be the responsibility of the Contractor. Repair or replacement of the damaged item(s) by the Contractor will be required, at no additional cost to the County, within ten (10) business days from date of notification.

OTHER AGENCIES:

The Contractor(s) **must** honor the prices, terms and conditions of this contract with political subdivisions or districts located in whole or in part within Monroe County. In addition, the contractor **may**, but is not required to, extend the prices, terms and conditions of this contract to any other political subdivision or district. Usage of this contract by any of these other political subdivisions or districts will have to be coordinated between that subdivision or district and the contractor. Orders placed against this contract between any subdivision or district will be contracts solely between the Contractor(s) and those entities. Monroe County will not be responsible for, nor will it have any liability or other obligation for, such contract between the Contractor(s) and any third party.

INDEMNIFICATION:

The Contractor agrees to defend, indemnify and save harmless the County, its officers, agents, servants and employees from and against any and all liability, damages, costs or expenses, causes of action, suits, judgments, losses and claims of every name not described, including attorneys' fees and disbursements, brought against the County which may arise, be sustained or occasioned directly or indirectly by any person, firm or corporation arising out of or resulting from the performance of the services by the Contractor, arising from any act, omission or negligence of the Contractor, its agents and employees or arising from any breach or default by the Contractor under this Agreement. Nothing herein is intended to relieve the County from its own negligence or misfeasance or to assume any such liability for the County by the Contractor.

SPECIFICATIONS

**ACCEPTANCE AND
PREPARATION OF
SURFACE:**

The contractor shall inspect the sub-flooring before beginning work. He shall notify the County in writing of any conditions which will prevent a satisfactory finished product. The contractor shall also broom-clean and prepare the floor to receive the tile. Installation of tile shall be an indication of the acceptance of sub-floors and waive any claim for unacceptable work caused by unsatisfactory sub-floor conditions.

INSPECTION:

The County at any time may require removal of tile for inspection. Exacting workmanship shall be enforced. Uneven surfaces, ill-fitting cuts, and loose tiles will be grounds for rejecting the work.

CLEAN-UP:

Upon completion of installation, the contractor shall remove all waste and excess materials, tools, and equipment. He should carefully vacuum clean the entire surface; damp mop with a dilute, neutral detergent solution such as Armstrong S-485 Floor Cleaner; and carefully wipe up black marks and excessive soil. He shall apply two coats of high-quality commercial floor polish such as Armstrong S-480 and must not wash, scrub, or strip the floor for at least four-to-five days after installation.

MASTIC:

The contractor shall provide the type and quality of mastic as recommended by the manufacturer.

ESTIMATES:

Prior to the start of any job, the contractor must submit a quotation for the job cost, including materials and labor. The quote must be approved and a start-work order issued before the contractor is to proceed.

MINOR VARIATIONS:

Minor variations in the specifications will be acceptable. However, vendors must indicate on their proposals, or on a separate attachment, the area in which their products deviate from the specifications.

VINYL BASE:

Vinyl base shall be standard top-set cove, 4" high, 1/8" gauge, complying with FS SS-W-40, Type II, as manufactured by Roppe Corporation. Installed per manufacturer's written instructions, using manufacturer's recommended adhesives. Up to four (4) colors shall be selected by the County.

FLASH PATCHING:

Material to smooth and level floors shall be Ardex SD-F by Ardex Engineered Cements, Inc., self-drying, Portland cement matrix chemically combined with water only to produce a creamy, smooth consistency. Mixing and application as per manufacturer's written instructions.

RESTRETCHING:

When required to do so the contractor must restretch the carpet within one (1) year of the original installation at no additional cost to the County.

Interface Carpet Tile Specification

Carpet tile to be Interface branded, textured loop pile construction. Colour, texture and pattern are tufted into each tile. The carpet tile is constructed to be 'unzippered' so that fibre and backing can be recycled. Tufted pattern in each carpet tile is to be of random design and be dye batch mergeable.

Carpet tile is warranted for 15 years against excessive wear and manufacturing defects, electrostatic propensity, dimension stability and castor chairs.

Yarn System is 100% solution dyed nylon and contains (on average) recycled content in excess of 25% to 50% depending on yarn system used. Backing System contains (on average) recycled content in excess of 50%. Carpet tile contains post-consumer recycled content.

Carpet tile contains lifetime anti-microbial properties.

Carpet tile is certified 'climate neutral' by acknowledged third party verification (SBS) for the entire life cycle of the carpet tile. The carpet tile contains both Environmental Choice Certification & Green Tag Gold+ certification. Carpet tile provides maximum points available under the NZGBC Greenstar tools.

INZIDE Commercial will take back carpet tile at the end of its life and recycle into new tile or find a re-use opportunity for it.
